Reefer Requirements (for reefer shipments only)

Detention

Submit requests for detention payment in the Uber Freight App or at t.uber.com/detention. If the carrier's designated driver is not using the Uber Freight App, they must call 844-822-UBER at least 30 minutes prior to entering detention or the request may be denied. Detention starts 2 hours after the scheduled appointment and maxes out at 5 hours

Accessorial policy

Powerloop Empty Trailer Dropoff Location

Powerloop Empty Trailer Dropoff Time

After completing a Powerloop load, the carrier can utilize the Powerloop trailer to haul their own backhaul, another Uber Freight load, or return the trailer empty. Powerloop Trailer Damage

Cancellations

If a load is cancelled by your carrier, you will be able to rebook the load as long as it's still available.
